

CARROLL COUNTY ORDINANCE NO. 35

AN ORDINANCE OF THE COUNTY OF CARROLL, IOWA, ESTABLISHING ELECTION PRECINCT BOUNDARIES PURSUANT TO IOWA CODE SECTION 49.4.

BE IT ENACTED by the Carroll County Board of Supervisors;

SECTION 1. NEW ORDINANCE. The Code of Ordinances of the County of Carroll, Iowa is hereby amended by the adoption of this ordinance.

SECTION 2. DIVISION INTO ELECTION PRECINCTS. Carroll County is divided into thirteen election precincts as follows:

1. Precinct #1, referred to as Carroll Ward One (First Ward), shall include all that part of the City of Carroll lying, for the most part, north and east of the following described lines: Beginning at the northern corporate limits, located approximately eleven hundred seventy-two feet north of the intersection of North West Street and Thirtieth Street; thence southerly along the center of corporate limits and all described streets to the centerline of Fairway Heights; thence easterly and southerly to the centerline of Randall Road; thence easterly to the second centerline of Todd Terrace; thence easterly to the centerline of Grant Road; thence southerly to the centerline of Eighteenth Street; thence westerly to the centerline of Pike Avenue; thence southerly to the centerline of Bass Street; thence easterly to the centerline of Grant Road; thence southerly to the centerline of Parkview Drive; thence easterly to the centerline of Vine Street; thence southerly to the centerline of Eleventh Street; thence easterly to the centerline of Forest Street; thence southerly to the centerline of Woodland Drive; thence easterly to the centerline of Bella Vista Drive; thence southerly to the center of U. S. Highway 30; thence easterly to the east corporate line.
2. Precinct #2, referred to as Carroll Ward Two (Second Ward) & the North Half of Maple River Township, shall include all of the unincorporated area of Maple River Township that is North of U.S. Highway 30; and all that part of the City of Carroll lying, for the most part, north and west of the following described lines: Beginning at the northern and western corporate limits, located approximately one hundred feet north of the intersection of North West Street and Fairway Heights; thence southerly along the center of all described streets to the centerline of Fairway Heights; thence easterly and southerly to the centerline of Randall Road; thence easterly to the second centerline of Todd Terrace; thence easterly to the centerline of Grant Road; thence southerly to the centerline of Eighteenth Street; thence westerly to the centerline of Pike Avenue; thence southerly to the centerline of Bass Street; thence easterly to the centerline of Grant Road; thence southerly to the centerline of Twelfth Street; thence westerly to the centerline of Adams Street; thence northerly to the centerline of Thirteenth Street; thence westerly to the centerline of North West Street; thence northerly to the centerline of Fourteenth Street; thence westerly to the centerline of Quint Avenue; thence northerly to the centerline of Fifteenth Street; thence westerly to the centerline of U. S. Highway 71; thence northerly to the centerline of Heires Avenue; thence westerly to the centerline of U.S. Highway 30; thence northwesterly and westerly to the corporate line, located approximately two thousand five hundred thirty-nine feet west of the centerline of Burgess Avenue.
3. Precinct #3, referred to as Carroll Ward Three (Third Ward) and the South Half of Maple River Township, shall include all of the unincorporated area of Maple River Township that is South of U.S. Highway 30; and all that part of the City of Carroll lying, for the most part, south and west of the following described lines: Beginning at the west corporate line, located approximately two thousand five hundred thirty-nine feet west of the centerline of Burgess Avenue, at the centerline of U. S. Highway 30 and following the centerline of all described streets, thence east and southeasterly to the centerline of Heires Avenue, thence easterly to the centerline of U. S. Highway 71, thence southerly to the centerline of Fifteenth Street; thence easterly to the centerline of Quint Avenue; thence southerly to the centerline of Fourteenth Street; thence easterly to the centerline of North West Street; thence south to the centerline of Thirteenth Street; thence east to the centerline of Adams Street; thence southerly to the centerline of Twelfth Street; thence easterly to the centerline of Main Street; thence southerly to the centerline of Timberline Road; thence westerly to the centerline of Hidden Valley Road; thence southerly to the corporate line.

4. Precinct #4, referred to as Carroll Ward Four (Fourth Ward), shall include all that part of the City of Carroll, for the most part, south and east of the following described lines: Beginning at the east corporate line at U.S. Highway 30, following the centerline of all described streets, thence westerly along U. S. Highway 30 to the center line of Bella Vista Drive; thence northerly to the centerline of Woodland Drive; thence westerly to the centerline of Forest Street; thence northerly to the centerline of Eleventh Street; thence westerly to the centerline of Vine Street; thence northerly to the centerline of Parkview Drive; thence westerly to the centerline of Grant Road; thence northerly to the centerline of Twelfth Street; thence westerly to the centerline of Main Street; thence southerly to the centerline of Timberline Road; thence westerly to the centerline of Hidden Valley Road; thence southerly to the corporate line.
5. Precinct #5, referred to as Wheatland-Kniest Precinct, shall include all of Wheatland Township and Kniest Township, including the incorporated city of Breda.
6. Precinct #6, referred to as Sheridan-Grant-Jasper Precinct, shall include all of Sheridan Township, Grant Township, and Jasper Township, including the incorporated cities of Lidderdale and Lanesboro.
7. Precinct #7, referred to as Arcadia Precinct, shall include all of Arcadia Township, including the incorporated city of Arcadia.
8. Precinct #8, referred to as Glidden-Richland Precinct, shall include all of Glidden Township and Richland Township, including the incorporated city of Glidden and that portion of the incorporated city of Ralston that is located in Carroll County.
9. Precinct #9, referred to as Washington-Roselle Precinct, shall include all of Roselle Township and Washington Township, including the incorporated city of Halbur.
10. Precinct #10, referred to as Pleasant Valley-Newton Precinct, shall include all of Pleasant Valley Township and Newton Township, including the incorporated cities of Willey and Dedham.
11. Precinct #11, referred to as Ewoldt Precinct, shall include all of Ewoldt Township, including the incorporated city of Manning.
12. Precinct #12, referred to as Eden Precinct, shall include all of Eden Township, including the incorporated city of Templeton.
13. Precinct #13, referred to as Union Precinct, shall include all of Union Township, including the incorporated city of Coon Rapids.

SECTION 3. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 4. EFFECTIVE DATE: Said election precinct boundaries become effective for elections held after January 15, 2012 upon approval of said precincts by the Secretary of State and publication of the ordinance.
